In 2017, NLSLA provided assistance to 129,834 individuals and groups comprised of representation on 8,350 cases, help to 83,393 litigants at self-help centers and clinics, 38,091 through outreach and educational presentations, and linkages to mediation, other legal aids and other services. NLSLA also assisted hundreds of thousands of people through impact litigation.
