#### **Los Angeles County Superior Court:**

- All Traffic Arraignments and Trials have been continued for at least 30 days and are not an essential function of the Court at this time. People should contact the Traffic Court Clerk of the Courthouse where there the arraignment or trial was set to get more information about their new court date. #### **Los Angeles County Probation Department:**

- L.A. County Probation offices are closed to the public.
- The Department will continue to maintain frequent contact with clients. Deputy Probation Officers
  are reaching out to their clients by phone, focusing on the highest-risk offenders. Probation is also
  asking clients to proactively reach out to their probation officer.
- Probation clients are asked to contact their Probation Officer directly.
- Probation Adult Alternative Work Services (PAAWS) and the Juvenile Alternative Work Services (JAWS) also known as the Work Crew Services Program has been temporarily suspended.
   Participants will be notified when program activity resumes.
- Visitation at juvenile halls and residential treatment facilities remains temporarily suspended. These
  visits include after-court, special and weekend visits by family members and/or community-based
  organizations.
- Youth in juvenile facilities have received extended phone privileges to maintain contact with family and loved ones and all internal programming within the facilities will continue.

#### California Department of Corrections, Division of Adult Parole Operations (DAPO):
