ABOUT THIS POSITION:

The Case Manager will provide supportive services to individuals who are in need of information and resources to help meet basic needs and develop skills to self-sufficiency. The candidate must have a demonstrated passion and commitment and prior experience serving low-income individuals and client groups, with a sensitivity to those who have been impacted by trauma. The ideal candidate must possess strong organizational skills; be able to effectively work independently and have the ability to communicate verbally and in writing. The case manager will also collaborate with attorneys and advocates to support the client to understand and navigate various systems including but not limited to access to public benefits, law enforcement and other governmental agencies, Department of Child and Family Services, housing and others.

In this role, you would report to the Supervisor of Social Services and a career path may result in future opportunities. This position is non-exempt and temporary.

THIS POSITION MAY BE RIGHT FOR YOU IF:

- YOU THRIVE IN A FAST-PACED ENVIRONMENT and excel at moving through tasks and problem solving independently.
- YOU DON'T SWEAT THE SMALL STUFF and can maintain a positive attitude and goaloriented focus in an ever-changing and sometimes ambiguous environment.
- YOU KNOW THAT INTEGRITY MATTERS and exhibit a strong adherence to ethical standards including, but not limited to, the ability to maintain confidentiality and fiduciary responsibility.

WHAT YOU CAN EXPECT TO DO IN THIS ROLE:

- Responsible for intakes and comprehensive assessments of new referrals to identify client needs and barriers created by issues commonly associated with trauma and poverty.
- Create Service Plans in collaboration with clients to develop goals and timelines.

- Provide direct services based in client need and grant requirements which may include case management, individual counseling, support groups, court accompaniments and other linkage to outside providers.
- Provide client advocacy services that include coordination of services on behalf of the clients with social service and government agencies, court accompaniments, assistance obtaining police reports, DCFS support and other needed advocacy to address barriers created by domestic violence.
- Participate in community outreach and networking opportunities.
- Case management: provide direct referrals to resources and assist client with application process of these to successfully link to outside agencies that will support client goals.
- Document information on each client, maintain written records, create, and provide reports and letters as requested.
- Travel to other NLSLA branch offices, courts, government agencies, shelters and community-based organizations throughout the Antelope, San Fernando and San Gabriel Valleys required.

HOW YOU CAN STAND OUT:

For this role, the ideal candidate has

- Knowledge of trauma-informed practices and a minimum of one year of prior experience working with underserved/unserved communities.
- Prior experience providing direct client services to survivors of domestic violence.
- The candidate must excel in a fast-paced and dynamic environment while demonstrating commitment to serving low-income individuals and client groups, with a sensitivity to those who have been impacted by trauma.
- Bachelor's degree in social work or related field.
- Bilingual proficiency.

WHAT YOU'LL NEED ON DAY ONE:

- Working knowledge of Microsoft Outlook, Word and Excel, business communication platforms, and web-based case management platforms.
- Passion for NLSLA mission and demonstrated commitment to advocating for the legal rights of low-income individuals.
- Passion, empathy, and compassion for supporting people from different lived experiences.

WHAT WE OFFER:

The salary range for this position is \$43,000-\$47,000.
